Subject: Re-Designation of District 31 As District 7

## RESOLUTION

WHEREAS, Article VI Section 1 of the Bylaws of The Department of California defines District 31 as encompassing the areas of El Dorado, Nevada and Placer Counties in the State of California, and

WHEREAS Article VII of the Bylaws of The Department of California includes District 31 in the definition of Area One, and

WHEREAS there is currently no District 7 organized and/or identified within The Department of California, and

WHEREAS the Posts of District 31 have expressed the desire to have District 31 re-designated as District 7 within The Department of California, and

WHEREAS the Posts of District 31 have formally requested that District 31 be re-designated as District 7 by the enactment of a resolution requesting such action dated June 3, 2007, and

WHEREAS there is no evident legal reason that District 31 should not be re-designated as District 7 and no majority opposition to the requested re-designation has been raised, NOW, THEREFORE, BE IT


RESOLVED by The American Legion Department of California, in convention assembled in Palm Springs, California, June 22-24, 2007, that Article VI Section 1 of the Bylaws of The American Legion Department of California is amended to add "**District No. 7:** El Dorado, Nevada and Placer Counties", and BE IT FURTHER

RESOLVED that the part of Article VI Section 1 of the Bylaws of The Department of California reading "**District No. 31:** El Dorado, Nevada and Placer Counties" be deleted, and, BE IT FURTHER

RESOLVED that Article VII of the Bylaws of The Department of California be amended to add "**7**" and to delete "**31**" from the written definition of Area One, and, BE IT FINALLY

RESOLVED, that all references to "District 31" in all Department lists, rosters, registers and any and all paperwork within The American Legion Department of California be amended to reflect "District 7."
